

## First Million-Dollar Goal Reached

In May 1996 the SHSAA held its first Board Meeting. Items recorded in the Minutes from that meeting are very interesting. We reported that we had \$2,023.75 in total assets. The Minutes included

the following points:

A. Scholarship Awards. Motion made to limit the Scholarship Awards to interest earned only. Principal to remain invested. *Passed unanimously.* 

B. A \$100,000 Goal. Established a goal of a \$100,000 scholarship fund, from which we should be able to present approximately \$8,000 annually in awards. *Passed unanimously.* 

C. Scholarship Awarded.

A motion was made to award Emily A. Wallace with a \$100 scholarship from our operation/interest funds. *Passed unanimously*.

D. Name Change. A motion made to change the name from SUHS Alumni Association to SHS Alumni Association. Discussion: school was SHS before1954 and will again be SHS in 1997. *Passed unanimously*.

It is clear that we exceeded our initial expectations and have surpassed our original goal of \$100,000 ten times over. During the summer of 2013 our investment account was nearing \$1,000,000. Having heard that we were approximately \$20,000 short of making our "First Million Dollars" Donna Homann Strom, '60, decided to help us reach the unbelievable goal by establishing a funded scholarship in her departed husband's name. The Doug Strom Scholarship was created and we had a million bucks in the bank.

We have gone from one scholarship in 1996 of \$100 to nearly 80 awards totaling almost \$60,000



in 2013 alone. We have given out approximately \$216,000 of interest earned from our SHSAA investment account to worthy Foxes since 1996.

Since 2008 we have also been given authorization by the Wells Fargo Bank to administer their Loar Fund scholarship program in support of Silverton alumni. Since the beginning of that association, we have awarded over \$100,000 in Loar funds to fellow Foxes. Together the SHSAA and Loar scholarship combination has totaled well over \$316,000 in awards to our fellow Foxes to assist them in their pursuit of an undergraduate degree.

Some remarkable changes have occurred in the SHSAA since that first meeting. And everyone reading this article has had some supporting influences either spiritually, personally or financially in our unbelievable success.

Collectively we can now boast that we have one of the strongest High School Alumni Associations in the State and perhaps when com-

> pared to other similarly sized schools we have the credentials to perhaps claim to be the best.

Hopefully, our generation is planting the community service scholarship seeds in the next generation of Foxes so that our SHSAA will continue in perpetuity to assist young Foxes achieve undergraduate educational success. GO FOXES!

## **Named Scholarships**

Craig and Gladys Clark Scholarship – During the 1950's through the 1980's the Clark family owned and managed several downtown businesses to include: The Coast to Coast hardware store and Home Seeker's Realty. The Clark Estate made a significant donation to our Association in 2009 with the provision that a scholarship be awarded to an Alumnus who is pursuing undergraduate studies in a community college.

Shirley Doerfler Duerst (Class of 1954) Memorial Scholarship – The Duerst family has managed their family farm in the Silverton area for several generations. At Shirley's passing in 2010, many friends and family made significant memorial donations to our Associa-

tion in her name. Her scholarship is awarded to an Alumnus pursuing an undergraduate degree in Ag, Culinary Arts, Music or Nursing Major.

Clarence (Class of 1947) and Norma Medack Scholarship – The Medack family managed their family farm in the Silverton area for several decades. The Medack Estate made a significant donation to our Association in 2009 with the provision that a scholarship be awarded to an Alumnus who is pursuing an undergraduate degree in Agriculture.

Glen Damewood - Wooden Nickel Scholarship – For decades Glen and his family have owned and managed the Wooden Nickel and Wooden Nickel Catering Service. Every year he makes a very significant contribution to our Alumni Scholarship Fundraiser event. In recognition of his continuing generosity it is indeed a pleasure to award this scholarship.

Errol and Eaden Ross Scholarship – The Ross' family owned and operated the Shell heating oil and service station business in Silverton from 1930's for over 50 years. In 1993, the Ross Family Estate established an endowment from which annual scholarships may be awarded to alumni of SHS. Their Fund was merged with our Association in 2009 and remains today our most significant source for scholarship awards.

**Bill Dibala Scholarship** – Bill Dibala's family made a significant donation to honor him following his death in the spring of 2013. Bill was born with Downs Syndrome and lived 70 long years enjoying his work, the outdoors, people and his God. This scholarship is to be awarded annually to a SHS alumnus pursuing a degree that could lead to helping individuals with special needs. **Doug Strom Memorial Scholarship** – was established to recognize a SHS alumnus that demonstrates a belief in the value of hard work and seeks through a strong entrepreneurial spirit to succeed in private business. Typical fields of study include: Accounting, Business, Engineering and Mathematics

*Noteworthy:* The Dr. P. A. Loar Trust contributes approximately \$20,000 yearly to be managed and distributed by the Alumni Association. We typically award the LOAR funds to post-high school applicants and again this year we have made awards to 30 additional Alumni of SHS who are currently pursuing their undergraduate degrees. All of you who will be continuing their pursuit of an undergraduate degree are encouraged to apply again during early March of next year.

The Alumni Association has awarded 78 scholarships for a total of \$59,700 this year.

The first three recipes are favorites from my mom, Inga Anderson, long-time SUHS teacher, and are some of the only ones with actual instructions that I could find:

### **Best Ever Meatloaf**

Beat together (until bread disintegrates): 2 eggs 2/3 c milk 2 t salt 1/2 t pepper 3 slices of bread crumbled Add & mix well: 1 onion chopped 1 carrot grated 1 c grated cheddar cheese 1 1/2 lb. ground beef Combine: 1/4 c brown sugar 1/4 c catsup 1 T prepared mustard Shape meat mixture into a loaf and place in a loaf pan. Spread catsup mixture on top. Bake at 350 for 1 hour. Cool 10 minutes before slicing.

### **Apple Bread**

Combine<sup>.</sup> 1/2 c butter 2 eggs 1 c sugar 1 tsp vanilla Combine and add to first mixture: 2 c. flour 1 tsp. soda 1/2 tsp. salt (Dough will be very stiff) Add: 3 c. chopped apples 1/2 c. chopped nuts Turn dough into two greased 9" by 5" loaf pans and spread with topping. Topping: Heat until bubbly: 3 T sugar 2 T butter 1 t cinnamon Bake at 350 degrees for 45-55 minutes. Loaves will be quite small.

### Manhattan Clam Chowder

Becky Anderson Pharris '69 7 strips of bacon 1 c. celery 1 large onion, chopped 2 c. diced potatoes 1 c. diced carrots 1 can (14 oz.) chicken broth  $1 \frac{1}{2}$  c. water 2 cans (14.5 oz. each) of diced tomatoes 3 cans (6.5 oz. each) of chopped clams with their juice 1 t. thyme or to taste salt and pepper to taste Fry bacon in large skillet over medium heat until cooked through but not crisp. Add celery and onion and fry until onion is transparent. In large soup pot, combine remaining ingredients except clams. Add onions, celery, and bacon to the pot and bring to a boil. Turn down heat to low and simmer for at least 35 minutes (longer is better). Add clams with juice and serve.

### **Cranberry Ice**

Combine and freeze to mushy consistency:

bottle (32 oz.) cranberry juice
can pineapple juice
Juice of 2 oranges
1/2 c. sugar
When ready to serve, spoon into

glasses and add club soda, ginger ale, or champagne.

Anzac Biscuits
(Australian Air Corps)

Combine: 1 c. flour 1 c. brown sugar 1 c. oatmeal 1 c. coconut 1 pinch salt Combine: 1/2 c. melted butter
1 scant t. baking soda
2 T boiling water
1 T light corn syrup
Combine and mix the two mixtures. Drop by teaspoonfuls on to
greased cookie sheet. Bake at 350
degrees for 8 minutes. Makes 30
cookies.

#### Easy Spinach Lasagna Becky Anderson Pharris '69

1/2 c. grated parmesan cheese 1 lb. small curd cottage cheese 1 1/2 c. shredded mozzarella cheese, divided 1 egg 1 pkg. (10 oz.) frozen chopped spinach, thawed and drained 1 t. salt 1 t.oregano 1/4 t. pepper 1 qt. of spaghetti sauce Approx. 1/2 package lasagna noodles (do not precook) 1 c. water In a large bowl, mix parmesan cheese, cottage cheese, 1 cup of the mozzarella cheese, egg, spinach, salt, oregano, and pepper. In a greased 13" x 9" x 2" baking pan, layer 1/2 c. spaghetti sauce, 1/3 of the noodles, and 1/2 of the cheese mixture. Repeat. Top with remaining noodles, and then with remaining spaghetti sauce. Sprinkle with remaining mozzarella cheese. Pour water around edges. Cover tightly with foil. Bake at 350 degrees for 1 hour and 15 minutes. Let stand for 15 minutes before serving. Makes 8 servings.

### Oversized Buttermilk Biscuits

Judy Taylor-Hurst '58 1 pkg. dry yeast 1 T. sugar

#### ---- SHS Alumni Recipes ----2 T. warm water Combine and let stand 5 minutes Stir mixture into 1/2 cup buttermilk and 2 cups Biscuit mix. Turn out on floured board and knead 5 times. Roll out to 1/2" thick. Cut with 3" cutter or tuna can. Place 1 inch apart on greased pan. Prick tops. Let rise about 30-40 minutes until puffy. Bake at 400° for 12-15 minutes. Serves 6. Christmas morn with sausage gravy - YUM!

### **GERMAN CABBAGE**

Donna Krug Ramseyer Liechty '41 4 Tbsp. bacon fat 3/4 c. vinegar 3 lg. onions, chopped 3/4 c. water 1 med. head red cabbage, chopped 3/4 c. sugar Saute onions in bacon fat in

large skillet. Add chopped cabbage and cook 20 minutes, stirring. Add water, vinegar and suagr and steam covered 30 to 60 minutes - slow. You may have to add more water and sugar and vinegar to taste.

Goes very well with Oktoberfest sausage or pork.

### SAUERKRAUT DISH

Donna Krug Ramseyer Liechty '41

- 4 strips bacon 4 or more potatoes
- 1 lb. ground beef
- Nutmeg to taste
- 1 qt. sauerkraut

Cut bacon in small pieces and fry 3-5 minutes. Add ground beef to (electric) skillet and cook with bacon until no more red shows. Turn several times so that beef and bacon are mixed together. Drain the sauerkraut and rinse with water to cut sourness. Spread sauerkraut over meat. Sprinkle with nutmeg according to taste. (I use a generous amount.) Turn skillet to simmer and cook 1 hour. While kraut and meat are cooking, pare and cook potatoes. When tender, mash potatoes. As soon as sauerkraut is finished, spread potatoes over kraut and meat. Dot with butter or margarine and serve. This is a Dutch dish.

### **SWEET AND SOUR BAKED BEANS**

Donna Krug Ramseyer Liechty '41 8 slices bacon 4 med. onions, sliced 1/2 c. brown sugar 2 (15 oz.) cans butter beans 1/2 c. vinegar 1 (1 lb.) can green lima beans 1 tsp. mustard 1 (1 lb.) can red kidney beans 1 tsp. salt 1 (1 lb.) can baked beans 1/2 tsp. garlic salt Fry bacon till crisp; set aside. Separate onions into rings and cook in bacon fat till tender but not brown. Stir in sugar, vinegar and spices. Cover; simmer 20 minutes. Drain all the beans and mix with onion mixture and bacon. Turn into 3-quart casserols and baket at 350° for 1 hour. Serves 12. Great with barbecues.

### **COQ AU VIN (CHICKEN** IN WINE)

- Marcia & Mason Branstetter '63 3 lb. chicken breasts, deboned 1 garlic clove, minced 1/4 c. butter
  - 2 Tbsp. flour
  - 8 small boiling onions
  - 1 small bay leaf

2 c. dry red wine (Note: I use white wine)

- 1 c. button mushrooms
- 1 Tbsp minced parsley

 $1 \frac{1}{2}$  tsp. salt 8 small carrots

1/4 tsp. pepper

Melt butter in skillet and brown chicken. Remove: set aside. Put onions and carrots in and brown slightly. Add garlic, stir in flour and then gradually the wine. When well blended, add spices. Pour in liquid from mushrooms. Add salt & pepper. Return chicken and add mushrooms. Cover and simmer 20-30 minutes until vegetables and chicken are tender. Serves 4-6.

### **BAKED BEANS**

Nellie Graves '56 (A recipe from my niece) 2 # 2 1/2 cans pork & beans 1/2 lb. lean bacon 2 med. onions 1/2 cup brown sugar 1 lg. green pepper 2 tsp. Worcestershire sauce 1 cup catsup Cut bacon into pieces and cut

onion & peppers into chunks. Combine all ingredients. Bake covered at 325° for 3 hours, stirring occasionally. Remove cover for the last 30 minutes to brown.


